



## **Municipality of Skagway Request for Bids – 1986 GMC Fire Truck**

The Municipality of Skagway is accepting bids by interested parties for the purchase of a 1986 GMC Fire Truck, series TC 7D042.

**A minimum bid price of \$4000** (Four Thousand Dollars 00/100) for the Fire Truck is required. The truck may be viewed at the Public Safety Facility, 17<sup>th</sup> and State St. Skagway, Alaska.

Interested parties must complete the attached form and return it to the Municipality of Skagway in a sealed envelope clearly marked “1986 GMC Fire Truck” no later than 4:00 p.m., September 12, 2017. The award of the bid will be based on the highest bid amount submitted. If the form is not completed properly, the bid will be considered non-responsive and will not be accepted. Interested parties may pick up a copy of the bid form at the Municipal Offices at 7<sup>th</sup> & Spring Street or at [www.skagway.org](http://www.skagway.org).

Once the bid is awarded, the successful bidder is responsible for the removal of the Fire truck from Municipal property. The vehicle must be removed from the premises no later than September 30, 2017. The Municipality of Skagway is not responsible for any costs incurred in the removal or delivery of this item. It is the sole responsibility of the successful bidder to remove the Fire truck from the premises.

The Municipality of Skagway is not liable for any injury pertaining to the removal of the Fire truck from Municipal property or for any injury resulting from the use of the Fire truck, proper or improper, after the purchase and removal.

Bids may be mailed to the Municipality of Skagway, P.O. Box 415, Skagway, AK 99840 or dropped off to Skagway Municipal offices located on 700 Spring Street. Postmarks will not be accepted. Interested parties must ensure delivery by the due date and time. Faxes and e-mails will not be accepted.
