A RESOLUTION OF THE CITY OF KAKE AUTHORIZING A DECLARATION OF DISASTER EMERGENCY

- WHEREAS, COVID-19 is a respiratory disease that can result in serious illness or death and is easily transmittable person to person; and
- WHEREAS, on March 11, 2020, the World Health Organization ("WHO") declared the virus a pandemic; on the same day Alaska Governor Dunleavy issued a declaration of public health disaster emergency in response to the anticipated outbreak of CO VID-19 in Alaska; and
- WHEREAS, a positive case of COVID-19 has been identified within the State of Alaska; and
- WHEREAS, on march 13, 2020, Governor Dunleavy closed all schools in Alaska for two weeks; and
- WHEREAS, On March 18, 2020, Mayor Lloyd Davis requested that public refrain from visiting the City of Kake, and instead use other forms of communication (telephone, email, or mail to submit payments; and
- WHEREAS, on March 19, 2020, Mayor Lloyd Davis suspended all non-residential travel into Kake, Alaska, and requested anyone travelling to Kake, self-quarantine for 14 days, and
- WHEREAS, the declared pandemic has the potential to negatively affect the City Kake's economy, in addition to the ability to ensure there are essential supplies, for the Kake residents, and
- WHEREAS, a declaration of disaster emergency will alert the public to the seriousness of the risk and provide direction to residents of sources of information other available public health resources and allow the City of Kake to work in cooperation with other local, state and federal agencies to implement appropriate actions and responses to address the COVID-19 outbreak; and
