## INTER-VILLAGE TRAVEL GUIDELINE UPDATE

ALL INCOMING TRAVELLERS TO THE NATIVE VILLAGE OF KWIGILLINGOK, WHETHER BY AIRCRAFT, BOAT, SNOWMACHINE, OR ATV'S WILL ABIDE BY THE FOLLOWING GUIDELINES:

1. ALL INCOMING TRAVELERS WANTING TO TRAVEL TO KWIGILLINGOK ARE REQUIRED TO OBTAIN PERMISSION/AUTHORIZATION FROM THE TRIBAL ADMINISTRATOR BY CALLING 907-588-2025 OR 907-588-8114, AND ON WEEKENDS, 907-588-2108, PRIOR TO TRAVELING TO KWIGILLINGOK.
2. YOU WILL NEED A WRITTEN STATEMENT FROM YOUR LOCAL HEALTH AGENCY OR TRIBAL OFFICE (TRIBAL ADMINISTRATOR) CONFIRMING THAT YOU ARE IN GOOD HEALTH AND HAVE NOT TRAVELED TO A HIGH RISK ZONE (BETHEL, ANCHORAGE AREA AND OTHERS).
3. YOU WILL BE REQUIRED TO USE PRECAUTIONARY MEASURES TO INCLUDE WEARING A FACE MASK UPON ENTERING THE COMMUNITY. ONCE YOU HAVE RETURNED HOME, PLEASE BE MINDFUL OF YOUR HEALTH CONDITIONS FOR ANY CHANGES.
4. IF YOU HAVE A FAMILY OR HOUSEHOLD MEMBER UNDER QUARANTINE, YOU WILL BE DENIED PERMISSION TO ENTER THE NATIVE VILLAGE OF KWIGILLINGOK TO CONDUCT PERSONAL OR OTHER BUSINESS.
5. ALL TRAVELERS REQUESTING TO TRAVEL TO KWIGILLINGOK MUST QUARANTINE FOR 14 DAYS UPON ARRIVAL AND ADHERE TO GUIDELINES INCLUDING NOT TO VISIT OTHER FAMILIES, HOMES, AND PUBLIC AREAS DURING THE PERIOD OF QUARANTINE. THERE ARE NO EXCEPTIONS TO THIS GUIDELINE OTHER THAN THOSE DEEMED TO BE ESSENTIAL WORKERS.
6. ALL NON-ESSENTIAL TRAVEL IS PROHIBITED. PLEASE CONTACT THE KWIGILLINGOK I.R.A. COUNCIL FOR FURTHER INFORMATION AT (907)588-8114 OR (907)588-2025.
7. NO INCOMING TRAVELERS WILL BE ALLOWED FROM A COMMUNITY THAT IS ON A LOCK DOWN STATUS.
8. ALL PERSONS ENTERING KWIGILLINGOK MUST ABIDE BY THE NATIVE VILLAGE OF KWIGILLINGOK COVID-19 MANDATES.
