## **ATKA COVID-19 MODIFIED TRAVEL RESTRICTIONS**

EFFECTIVE: May 3, 2021 AT 11:59PM

Per City of Atka ordinance, the following Covid-19 related travel restrictions will be in place for those entering the City of Atka for the next 30 days, until June 3, 2021:

**Travelers arriving in Atka by plane or boat are required to observe the following safety protocols, depending on each traveling individual's vaccination status:**

- 1. Individuals NOT FULLY Vaccinated [i.e. those who have *not* received full course of vaccination at least 2 weeks prior to arrival in Atka] or those without proof of vaccination:**
  - (1) Must wear a mask** upon arrival and any time outside of dwelling.
  - (2) Quarantine for 10 days upon arrival**, along with any individuals sharing living space.  
Do not enter public places such as the store, post office or other public office buildings, and do not travel inside a vehicle with other individuals not sharing living space. Being outside away from other individuals is allowed.
  - (3) Observe social distancing guidelines of no less than 6 feet** from other individuals any time outside of dwelling.
  - (4) Submit to the Covid-19 nasal swab testing** by health personnel on 10th day after arrival.
- 2. Individuals with proof of FULLY Vaccinated status [i.e. at least 2 weeks past full course of vaccination prior to arrival in Atka]:**
  - (1) Provide proof of vaccination status to the City of Atka prior to travel or upon arrival.**
  - (2) Submit to Covid-19 nasal swab testing** by health personnel on day of arrival, as well as the 10<sup>th</sup> day after arrival.
    - **In the event the initial, and all subsequent, Covid-19 nasal swab test results are 'negative', indicating absence of infection with the virus**, individuals will *not* be required to quarantine, but **MUST** wear a mask around anyone not sharing the same dwelling for 10 days or for the duration of their stay if fewer than 10 days. Any others staying in the same home/dwelling must also wear a mask around other people for 10 days.
    - **In the event that any Covid-19 test result is 'positive', indicating infection with the virus**, individuals must immediately self-quarantine and comply with health protocols as determined by local health care personnel.
  - (3) Maintain social distance (not less than 6 ft.) from any unvaccinated individuals not sharing same dwelling for the 10-day duration**, pending a 'negative' Covid-19 test result on the 10th day.

**Freight, cargo, and mail services are still permitted.** Flight crews are asked to wear a face mask. Only City Employees are authorized to load and off-load the aircraft and are required to wear PPE. Post Office staff are also required to wear PPE while sorting mail.

The Atka City Council will re-evaluate this Travel Restriction protocol at the May 2021 City Council Meeting.
